DEAN'S LETTER

What kind of a tour guide are you?

In an old Saturday Night Live weekend update segment, the "reporter" would describe his trip to a popular tourist destination. After arriving in his hotel, he would spend the entire time in the hotel room, watching the complimentary cable TV channels, ordering room service, and never experiencing any of the real attractions of the destination. Whether he visited Disney World

or New York City, the experience was all the same---sit in the hotel room and watch TV.

As we close out the summer, I suspect that several of you may have had some period of vacation travel during the typical lull in the organ or church music season. You may have chosen a familiar destination, a place where you or your family has vacationed for many years, or you may have decided to explore a place you've never been. For those exploratory vacations, some choose to research the destination in advance, reading travel guidebooks and soliciting recommendations. Others will arrange for a tour, wherein a guide will highlight many of the major attractions of the destination. If you've ever taken an outstanding guided tour of a destination city, you've likely come away with a greater appreciation of the location, its historical significance, and perhaps the desire to return to select spots to explore further. Some of the best tour guides will ensure that they hit all the principal sites, and toss in a bit of "off the beaten track" side excursions. Outstanding tour guides are typically excited to share these destinations with you, and they want you to be excited about them as well.

Due to its historical significance, Philadelphia itself is a major tourist destination. Many of you have undoubtedly found yourselves thrust into the role of either tour guide or tourism consultant when friends or relatives come to visit the City of Brotherly Love. Depending on the interests of your guests, the number of times they have visited and the duration of their stay, you probably will suggest "must-see" attractions in the Philadelphia area. It would be quite common to suggest attractions of national significance, such as Independence Hall, the Liberty Bell, or Valley Forge. Typical guidance might be phrased, "If you haven't been there, you really should see Independence Hall, at least once." Other popular destinations include various art museums or the Franklin Institute. A fine tour guide or a good tourism consultant can allow the tourist to make the most efficient use of the limited time available, and may also ensure that the tourist can leave the destination excited about all that it has to offer, with great desire to return.

In like fashion, each of you who have the great privilege to play the organ for worship services act as tour guides to organ literature. Week after week, you are highlighting a destination for your "tourist" congregations. With the diminishing education in the arts in school systems, your role as tour guide is becoming increasingly important for providing the bulk of the music education your congregations may receive.

In this context, I ask, "What kind of a tour guide are you?" Have you ensured that your tourists have heard the major attractions, the great masterworks, of the organ repertoire? Or are your offerings the equivalent of staying in the hotel room and watching cable TV? If some of the "must hear" works are beyond you, have you shifted to the role of "tourism consultant," and arranged for a guest musician to visit and share additional repertoire? Are you excited about the works you are playing, and are you sharing that excitement with your congregation? Do they walk away knowing more about organ repertoire, and desiring to return to learn more? As you enter into the coming season, I challenge you to

Sadly, I must inform the membership of the passing on May 8, 2010 in Sarasota, FL of Dr. Eugene L. Szonntagh, *ChM*, at age 85. A former Dean of the Philadelphia Chapter during the years 1970-1972, he was born in Budapest, Hungary and immigrated to the USA with his family in 1956 to escape the Communist occupation. Dr. Szonntagh held diplomas in both the arts and sciences, was the recipient of 39 US patents, and served several Philadelphia churches before moving to Florida in 1982. He composed over 100 choral and

How Can I Keep From Singing

Mary Elizabeth Campbell

Many beloved hymns cross cultural, geographical and denominational boundaries, and often also flirt with pop culture. One such hymn is 'How Can I Keep From Singing.' This tune was apparently written by American Baptist minister Robert Wadsworth Lowry in 1860, author of 'Shall We Gather at the River.' There is ongoing uncertainly as to the author(s) of the words - maybe Lowry, or more possibly Anne Warner, a relatively obscure 19th century American writer. Pete Seeger learned it from family friend Doris Plenn, a Quaker who had learned it from her grandmother. Plenn described it to him as her favorite song, "made up years ago when people like us were thrown in jail for their beliefs." She herself wrote a verse during the 'Red Scare' era (around 1950) - "When tyrants tremble in their fear, and hear their death knell ringing..." This powerful hymn of faith was sung by abolitionist Quakers and has been incorrectly called a Quaker hymn. It was recorded through many generations and by very diverse performers, more recently including Bruce Springsteen and Enya.

I find this to be a beautiful faith statement that can also be very helpful in difficult times - which may explain its wide appeal. Not only is this lovely as a general hymn of praise, but its words become all the more poignant for funerals or other significant times of struggle. I learned it from a Canadian jazz vocalist, but then heard an absolutely gorgeous rendition for three part youth voices done by an elementary district choir. This has become a favorite in our parish crossing all generation and I've done my own arrangement for bells, instruments and SATB.

My life flows on in endless song, above Earth's lamentation.

I hear the real, though far-off hymn that hails a new creation.
